

### CSHP-BC BRANCH PHYSICAL ASSESSMENT COURSE FOR PHARMACISTS TRAVEL GRANT

The purpose of this grant is to help pharmacists who live remotely to attend the CSHP-BC Branch Physical Assessment Course held at the Langara College Main Campus in Vancouver, at the Royal Jubilee Hospital in Victoria or Kelowna General Hospital in Kelowna. The travel grant is provided by the College of Pharmacists of BC and all licensed BC pharmacists, not restricted to CSHP-BC Branch membership, are eligible to apply. The money is **subjected to fund availability** and will be allocated on a first come, first served basis. Applicants must submit their application at least 1 month prior to the start date of the course and receive an approval PRIOR to starting class.

For <b>VANCOUVER</b> Course ONLY

Non-Greater Vancouver Regional District (non-GVRD) residing pharmacists who commute to Vancouver by ground transportation may apply for:	\$250
Other non-GVRD residing pharmacists who require ferry rides or flights to Vancouver may apply for:	\$1000

For <b>VICTORIA</b> Course ONLY	
<i>Travel Grant Eligibility Criteria</i>	<i>Travel Grant Amount</i>
Pharmacists residing in Duncan or further north, but south of Campbell River may apply for:	\$250
Pharmacists residing in Campbell River or further north may apply for:	\$750

For <b>KELOWNA</b> Course ONLY	
<i>Travel Grant Eligibility Criteria</i>	<i>Travel Grant Amount</i>
Pharmacists residing in Kamloops or Salmon Arm may apply for:	\$250
Pharmacists residing in Trail, Nelson, 100 Mile, or Williams Lake may apply for:	\$500
Pharmacists residing in Cranbrook may apply for:	\$1000

Within one month after **successful** completion of the Physical Assessment course, the travel grant recipient must complete and submit the **CSHP-BC Branch Physical Assessment Course Reimbursement Claim Form** to CSHP Official in Ottawa for reimbursement. Travel grant recipients must be successful in completing the Physical Assessment course prior to claiming the travel grant. A cheque will be issued by CSHP Official for the reimbursable amount.
