

The CSHP Annual General Meeting will be held on Sunday, October 30, 2022 from 1:30-2:30pm EDT in-person at the Sheraton Four Points Hotel in Gatineau, QC and virtually via Zoom. Pre-registration is required by October 27, 2022. There will be two special resolutions that require a vote from membership regarding Articles of Amendment and a revision to By-law No. 1. More information is available here. I would encourage all CSHP members to attend the AGM via Zoom to ensure we achieve a quorum and to vote on these important resolutions.

The CSHP Fall Board Meetings will also be held on October 29-30, 2022 in Gatineau, QC. The Society will also be co-hosting a joint educational symposium (both in-person and virtually) with Association des pharmaciens des établissements de santé du Québec (APES) on October 28-29, 2022 entitled "Pandemic Takeaways for Hospital Pharmacy." This symposium will be a fully bilingual event with simultaneous translation offered to all participants. It will be accredited by CCCEP for five continuing education credits. The second offering of the CSHP Pharmacy Residency Application Roadmap is currently ongoing. The deadline for applications was August 29, 2022. This course offers didactic sessions and take-home activities focused on honing participants' practical skills through mock interviews and personal branding/marketing assignments. Participants will also have the opportunity to write a draft Cover Letter and Letter of Intent, and receive individualized feedback from practicing pharmacists.

Thank you to everyone who completed the 2022 CSHP Membership Survey. The results should be available to members in early 2023.

Banff is back! The Together Conference will be held again in 2023, but it will be a LIVE event at the Banff Centre. Save the date for March 10-12, 2023.




